# PROMOTING & PROTECTING SOCIO-ECONOMIC RIGHTS IN TIMES OF CRISIS IN EUROPE

The School of Law of UCLan Cyprus is pleased to announce an upcoming roundtable on social and economic rights in times of crisis which will take place on the **2**<sup>nd</sup> **March 2018 at 17:00** in **Nicosia**.

The aim of the roundtable is to bring judges of the national and supranational legal order and academics together to discuss the status of socio-economic rights in times of crises and methods that can be implemented to ensure the sustainable enjoyment of such rights. It seeks to provide an in-depth understanding of where socio-economic rights stand in the current financial crisis in the EU and within the framework of Member States. It will also consider the impact of the deterioration of socio-economic rights on a micro (individual), meso (group such as vulnerable groups) and macro (societal) level. The focus will be to move beyond a theoretical conceptualisation to a practical analysis of themes such as the substance of socio-economic rights, their application within the EU and new paradigms of reconceptualising this application. We are also pleased to announce that the former MEP, Ms. Barbara Weiler, will be a discussant for the presentations.
